LogServ is a full-service provider to the industrial logistics industry and has provided many years of service to the domestic large-scale industry. The customers of LogServ are primarily at home in metal production and processing, construction and processing industries, mechanical engineering and plant building and the automotive and automotive supply industries. In the railway sector, the company serves operators of plant and connecting railroads, private railway traffic companies and private freight car rental companies. At the voestalpine site in Linz, LogServ operates Austria's largest railway feeder line and its own Danube river port with efficient unloading facilities.

As a private railroad transportation company and as a subsidiary of LogServ, CargoServ provides alternative railroad strategies for block train freight transportation on the public railroad network.
